1. The M.Tech. dissertation is to be checked through Turnitin/Ithenticate software.
Following are the exclusions permitted while performing the check.
 - (a) All the quoted material.
 - (b) Bibliography/References.
 - (c) Small similarity from the sources that are less than 1%.
 - (d) Title page, table of contents, list of figures, list of tables, abbreviations, certificates, candidate's declarations.
 - (e) Acknowledgement
 - (f) Materials published by the student from the dissertation in journal/ conferences.
3. Acceptance level:
Overall similarity index should be less than or equal to 20%.
4. The language/ vocabulary used in Dissertation should be grammatically correct and sentences/words may not be in incorrect form.

Note: A certificate with regard to the exclusion of the material published by the student has to be issued by the supervisor in the specified format, through proper channel. Copy of the same is attached herewith for ready reference.

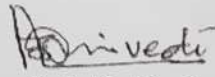
Sub : Regarding submission of Plagiarism report alongwith M.Tech. Dissertation.

On account of non submission of Plagiarism report, the evaluation process could not initiated. Therefore, it is requested that for the candidates who have already submitted their dissertations, concerned supervisors may be instructed to submit the Plagiarism report to Controller of Examination, RTU Kota alongwith cover page of the dissertation through Dean FA/respective Principal/Director, within seven days of issue of this letter. The evaluation process of above dissertations may be initiated after receiving the such report, failing which the dissertations may be returned back to respective department/college or may be kept pending untill the the report is received.

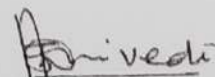
