- 2 The rates quoted should be FOR RTU, Kota inclusive of all charges e.g. packing forwarding, local taxes, railway freight, transit insurance etc.
- 3 GST: It will be paid extra, if admissible/applicable.
- As far as possible bids should be given for goods of Indian manufacture and foreign goods which are readily available. Normally it would not be possible for this office to supply import license. As such, foreign goods quoted and proposed to be supplied, should be covered by normal import quota of the dealers.
- Details specifications and make of each item should be clearly given supported by the illustrated pamphlets wherever possible. Bids without specifying the make and other particulars may be rejected, the payment will be made after the goods have been received, opened, checked and found to be in order and to our entire satisfaction. The accessories included in the equipment should also be clearly mentioned.
- 6 Losses or damage in transit will be to the account of the supplier, in case of rates FOR KOTA, The supplier may, if he so desires, get the goods insured and include such charges in the bided rate.
- Payment:- Payment shall be made through NEFT/RTGS within 30 days of the receipt of goods & installation to our entire satisfaction.
- 8 Your rates should be legally valid at least for Three months from the last date of the receipt of bid.
- 9 Liquidated Damages:- In case of extension in the delivery period with liquidated damages the recovery shall be made on the basis of following percentages of value of Stores which the bidder has failed to supply:-

1.)	a.	Delay up to one fourth period of the prescribed delivery period	21/2
	b.	Delay exceeding one fourth but not exceeding half of the prescribed period	5%
	C.	Delay exceeding half but not exceeding three fourth of the prescribed period	71/2

- (2.) Fraction of a day in reckoning period of delay in supplies shall be eliminated if it is less than half a day.
- (3.) The maximum amount of liquidated damages shall be 10%.

(4.) If the supplier requires an extension of time in completion of contractual supply on account of occurrence of any hindrance, he shall apply in writing to the authority, which has placed the supply order, for the same immediately on occurrence of the hindrance but not after the stipulated date of completion of supply.

(5.) Delivery period may be extended with or without liquidated damages, if the delay in

the supply of goods is on account of hindrances beyond the control of the bidder.

In case of failure to supply the goods within the prescribed time and in accordance with the specifications given in the bids, The RTU shall be free to cancel the order and make purchases from the next higher bid or form the open market as the case may be. In that case the loss sustained by the RTU shall be recovered from the defaulting supplier.

All legal proceedings, if necessity arises to institute any, by any of the parties RTU, or Contractor/Supplier) shall have to be lodged in the court situated at Kota and not

elsewhere.

Terms & Conditions/instructions to bidder:-

(i) The Prices shall be quoted FOR at RTU Kota.

- (ii) The price bid shall be quoted inclusive of all other charges i.e. Transportation, loading, unloading etc. However, statutory taxes i.e. GST shall be payable extra as applicable /prescribed by the government.
- (iii) The lowest bid (L1) shall be evaluated on total cost (including GST) basis only.
- (iv) Any discount i.e. quantitative discount and others may also be mentioned in details.

(v) Delivery Period shall be 15 days from the order date.

- (vi) Goods/Services will be provided within a stipulated period as mentioned in the conditions of tender. Payment shall not be made for defective items and such items must be removed from the site by the contractor without any cost.
- (vii) University reserves the right to increase or decrease the quantity of the items as per requirements.
- (viii) RTPP Rules, 2013 (read with GFAR) shall be applicable.

(ix) Payment shall be made after satisfactory supply of the items satisfactorily as per technical specifications.

(x) Pan No. and Bank Account details of the firm must be mentioned on bill /invoice

along with the Photocopy of PAN card.

(xi) Inspection, Installation & Demonstration: Bidder must note that the inspection site will be the Rajasthan Technical University, Kota only. No other place is acceptable, if there is any extra charges for installation and demonstration that must be included within rates of the items. Separate charges will not be paid on these accounts

(xii) Sample(s): Where the rates are asked with the sample or samples are required to prove the specification, The Bidder is bound to submit the sample, failing which their

Annexure A: Compliance with the code of Integrity and No Conflict of Interest

Any person participating in a procurement process shall-

- (a) Not offer any bribe, reward or gift or any material benefit either directly or indirectly in exchange for an unfair advantage in procurement process or to otherwise influence the procurement process;
- (b) Not misrepresent or omit that misleads or attempts to mislead so as to obtain a financial or other benefit or avoid an obligation;
- (c) Not indulge in any collusion, Bid rigging or anti-competitive behavior to impair the transparency, fairness and progress of the procurement process;
- (d) Not misuse any information shared between the procuring Entity and the Bidders with an intent to gain unfair advantage in the procurement process;
- (e) Not indulge in any correction including impairing or harming or threatening to do the same, directly or indirectly, to any party or to its property to influence the procurement process;
- (f) Not obstruct any investigation or audit of a procurement process;
- (g) Disclose conflict of interest, if any; and
- (h) Disclose any previous transgressions with any Entity in India or any other country during the last three years or any debarment by any other procuring entity.
 Conflict of Interest:-

The Bidder participating in a bidding process must not have a Conflict of Interest.

A Conflict of Interest is considered to be a situation in which a party has interests that could improperly influence that party's performance of official duties or responsibilities, contractual obligations, or compliance with applicable laws and regulations.

- A Bidder may be considered to be in Conflict of interest with one or more parties in a bidding process if, including but not limited to;
 - a. Have controlling partners/shareholders in common; or
 - b. Receive or have received any direct or indirect subsidy from any of them; or
 - c. Have the same legal representative for purpose of the Bid: or
 - d. Have the relationship with each other, directly or through common third parties, that puts them in a position to have access have to information about or influence on the bid of another Bidder, or influence the decision of the procuring Entity regarding the bidding process; or
 - e. The bidder participates in more than one bid in a bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all Bids in which the Bidder is involved. However this does not limit the inclusion of the same subcontractor, not otherwise participating as a Bidder, in more than one Bid; or
 - f. The Bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specification of the Goods, Works or Service that are the subject of the Bid; or
 - g. Bidder or any of its affiliates has been hired (or is proposed to be hired) by the procuring Entity as engineer-in-charge/consultant for the contract.

Annexure C: Grievance Redressal during Procurement Process

The designation and the address of the first Appellate Authority is Hon'ble Vice-Chancellor, RTU Kota.

The designation and the address of the Second Appellate Authority is **Secretary, Technical Education, Government of Rajasthan, Jaipur.**

(1) Filing an appeal

If any bidder or prospective bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the act or the rules or the Guidelines issued there under, he may file an appeal to First Appellate Authority, as specified in the Bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Providing that after the declaration of a Bidder as successful the appeal may be filled only by a Bidder who has participated in procurement proceeding:

Providing further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filled only by a Bidder whose Technical Bid is found to be acceptable.

- (2) The officer to whom an appeal is filed under Para (1) shall deal with the appeal as expeditiously as possible and shall endeavor to dispose it of within thirty days from the date of the appeal.
- (3) If the officer designated under Para (1) fails to dispose of the appeal filed within the period specified in Para (2), or if the Bidder or prospective bidder or the Procuring Entity is aggrieved by the order passed by the Procuring Entity, as the case may be, may file a second appeal to Second Appellate Authority specified in the Bidder Document in this behalf within fifteen days from the expiry of the period specified in Para (2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.
- (4) Appeal not to lie in certain cases

No appeal shall lie against any decision of the Procuring Entity relating to the following matters, namely:-

- (a) Determination of need of procurement;
- (b) Provisions limiting participation of Bidders in the Bid process;
- (c) The decision of whether or not to enter into negotiations;
- (d) Cancellation of a procurement process;
- (e) Applicability of the provisions of confidentiality.

(5) Form of Appeal

- (a) An appeal under Para (1) or (3) above shall be in the annexed Form along with as many copies as there are respondents in the appeal.
- (b) Every appeal shall be accompanied by an order appealed against, if any, affidavit verifying the facts stated in the appeal and proof of payment of fee.
- (c) Every appeal may be presented to First Appellate Authority or Second Appellate Authority, as the case may be, in person or through registered post or authorized representative.

(6) Fee for Filling Appeal

- (a) Fee for first appeal shall be two thousand five hundred and for second appeal shall be rupees ten thousand, which shall be non refundable.
- (b) The fee shall be paid in the form of bank demand draft or banker's cheque of a Scheduled Bank in India payable in the name of Appellate Authority concerned.
- (7) Procedure for disposal of appeal
- (a) The First Appellate Authority or Second Appellate Authority, as the case may be upon filing of appeal, shall issued notice accompanied by copy of appeal, affidavit and documents, if any, to the respondents and fix date of hearing.

- (b) On the date of fix hearing, the First Appellate Authority or Second Appellate Authority, as the case may be shall,-
 - (i) Hear all the parties to appeal present before him; and
 - (ii) Peruse or inspect documents, relevant records or copies thereof relating to the matter.
- (c) After hearing the parties, perusal or inspection of documents and relevant records or copies thereof relating to the matter, the Appellate Authority concerned shall pass an order in writing and provide the copy of order to the parties to appeal free of cost.

(d) The order passed under sub-clause (c) above shall also be placed on the State Public Procurement Portal.

Annexure D: Additional Conditions of Contract

1. Correction of arithmetical errors

Provided that a Financial Bid is substantially responsive, that Procuring Entity will correct arithmetical errors during evaluation of Financial Bids on the following basis:

- i. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quality, the unit price shall prevail and the total price shall be corrected, unless in the opinion in the Procuring Entity there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;
- ii. If there is a error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- iii. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error,in which case in the amount in figures shall prevail subject to (i) and (ii) above.

If the Bidder that submitted the lowest evaluated Bid does not accepted the correction of errors, its Bid shall be disqualified and its Bid Security shall be forfeited or its Bid Securing Deceleration shall be executed.

2. Procuring Entity's Right to very Quantities.

- (i) At the time of award of contract, the quantity of Goods, works or services originally specified in the Bidding Document may be increased or decreased by a specified percentage, but such increase or decrease shall not exceed twenty percent, of the quantity specified in the Bidding Document. It shall be without any change in the unit price or other terms & conditions of the Bid and the conditions of contract.
- (ii) If the Procuring Entity does not procure any subject matter of procurement or procures less than the quantity specified in the Bidding Document due to change in circumstances, the Bidder shall not be entitled for any claim or compensation except otherwise provided in the Conditions of Contract.
- (iii) In case of procurement of Goods or services, additional quantity may be procured by placing a repeat order on the rates and conditions of the original order. However, the additional quantity shall not be more than 50% of the value of Goods of the original contract and shall be within one month from the date of expiry of last supply. If the Supplier fail to do so, the Procurement Entity shall be free to arrange for the balance supply by limited Bidding or otherwise and the extra cost incurred shall be recovered from the Supplier.

3. Dividing quantities among one than more Bidder at the time of award (In case of procurement of Goods)

As a general rule all the quantities of the subject matter of procurement shall be procured from the Bidder, whose Bid is accepted. However, when it is considered that the quantity of the subject matter of procurement to be procured is very large and it may not be in the capacity of the Bidder, whose Bid is accepted, to deliver the entire quantity or when it is considered that the subject matter of procurement to be procured is of critical and vital nature, in such cases, the quantity may be divided between the Bidder, whose Bid is accepted and the second lowest Bidder or even more Bidders in that order, in a fair, transparent and equitable manner at the rates of the Bidder, whose Bid is accepted.
