At the outset, all the members of Academic Council were welcomed.

The meeting started with the lamp lighting and offer prayer to Her Holiness "Maa Saraswati" by Chairman along with members. The National Anthem was played. The Member Secretary and Registrar read out the agenda with permission of Chair. The agenda & resolution are as follows:

AC-40.1 To consider and pass the grace for conferment of degrees in XIV Convocation- 2025 to students passed out in examination year 2024 or before, for UG, PG and Ph.D. Program.

Students who have passed their B.Tech., B.Arch., BHMCT, BBA, MBA, MCA, M.Tech. and M.Arch. course in examination year 2024 and get subsequent result on or before 31st January, 2025 may be considered for passing the grace for conferment of degrees in 14th Convocation-2025. For Ph.D. program the last date for eligibility has recommended by the Core committee 10th March, 2025 and subsequent approval of Hon'ble Vice Chancellor.

Therefore, the Council is requested to pass the grace for conferment of degree to pass-out students of B.Tech., B.Arch., BHMCT, BBA, MBA, MCA, M. Tech. and M.Arch. courses in the examination year 2024 and cleared their eligibility on or before 31st January, 2025 & for Ph.D. students on or before 10th March, 2025 and record date of conferment of degree/Gold Medals is 20th March, 2025_as approved by Hon'ble Vice Chancellor. (Annexure 40.1 Page No.01-06)

Further, Council is also requested to authorize Hon'ble Vice-Chancellor to include such other students afterwards who have completed their degrees up to 31stJanuary, 2025 but their names could not include in the Degree Register at present.

AC-40.2 To consider and approve the Chancellor's and Vice-Chancellor's Gold Medal at the XIV Convocation of the University.

Hon'ble Chancellor has directed vide its letter no. DO no. F1(39)RB/2016:7927 dated 28.09.2016 to institute Chancellor's Gold Medal to the topper of post- graduation course in any one stream. This medal shall be awarded each year by rotation system.



In view of Raj Bhawan direction, the compliance report was submitted vide RTU letter no. RTU/VCS/F(1)5/2016 dated 29.11.2016 and roster of rotation was also communicated.

The matter was placed before Academic Council at its 24th meeting vide agenda item no. 24.3 and approved the roaster of rotation of Chancellor's Gold Medal and also decided the institution of Vice-Chancellor's Gold Medal to highest topper of B.Tech. course.

This year Chancellor's Gold Medal will be awarded to overall topper of P.G. Program in Master of Technology i.e. M. Tech. course, who were admitted in batch 2022-23 and have submitted their dissertation on or before 31st August, 2024 and the result of dissertation has been declared on or before 31st October, 2024(Annexure 40.2.1 Page No. 07-13)

Further, it was resolved that the last date of submission of Dissertation and Viva-Voce will also be considered 31th August and 31st October of respectively of the respective year for next sessions.  - 1. As per University rules, a student admitted in B. Tech, B. Tech. (LEEP), BHMCT, B. Arch., BBA, MCA, MCA (Lateral Entry), MBA, M. Tech. & M. Arch. course is required to complete his/her course/degree in 8, 7, 8, 10, 6, 6, 5, 4, 4 & 4 years duration respectively i.e. double the duration prescribed for the course.
 - 2. Previously, as per decision of Academic council and BOM, the students of B. Tech. 2006 to 2016 (LEEP 2007 to 2017), BHMCT 2006 to 2016, B. Arch. 2006 to 2014, BBA 2013 to 2018, MCA 2006 to 2018 (MCA Lateral Entry 2016 to 2019), MBA 2006 to 2020, M. Tech. 2006 to 2020 & M. Arch. 2006 to 2020 admitted batches were given mercy chances and additional mercy chances who could not pass all papers and did not complete their degree within the stipulated/permitted period. In this context it is proposed to grant of a mercy chance to students of B. Tech. 2017 LEEP (B. Tech.) 2018, BHMCT 2017, B. Arch. 2015, BBA 2019, MCA (three year course)
